Preliminary patent will provide intellectual protection in most countries where PFAS is or is expected to be an issue.

PFAS is a growing concern with successful litigation, and increased government intervention in an attempt to reduce the harmful impacts.

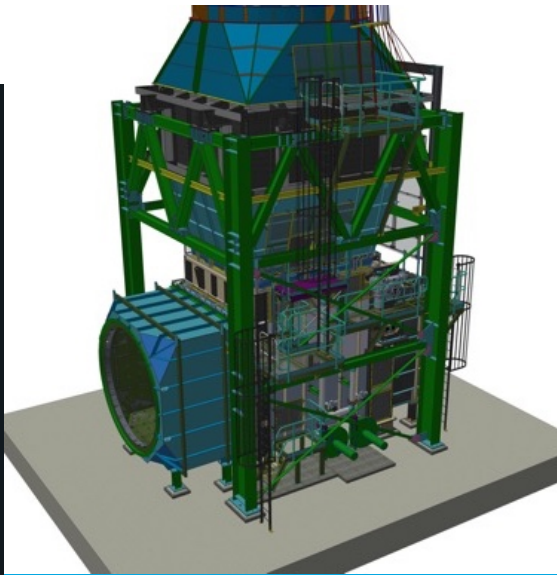

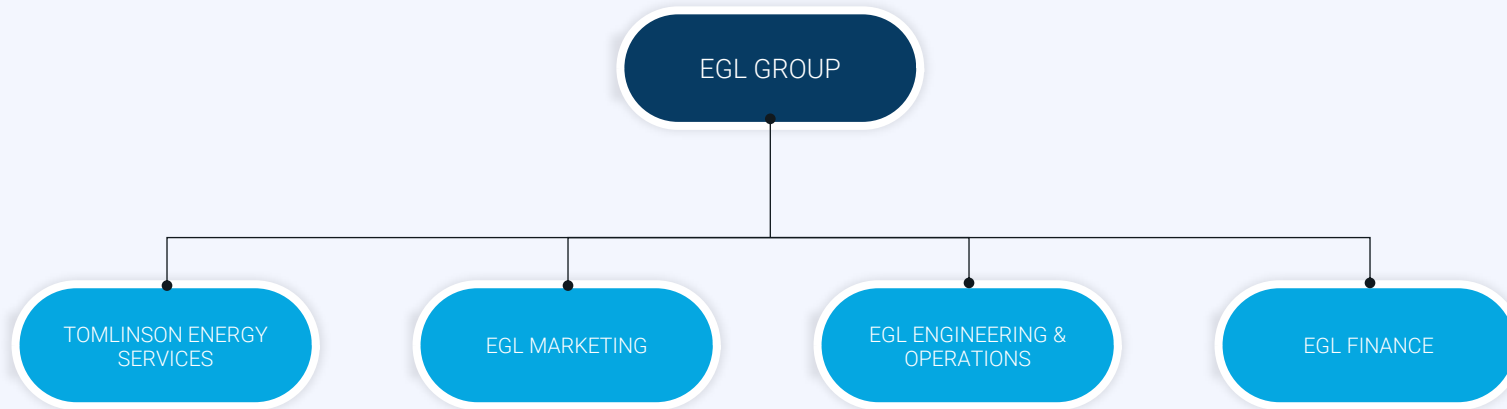

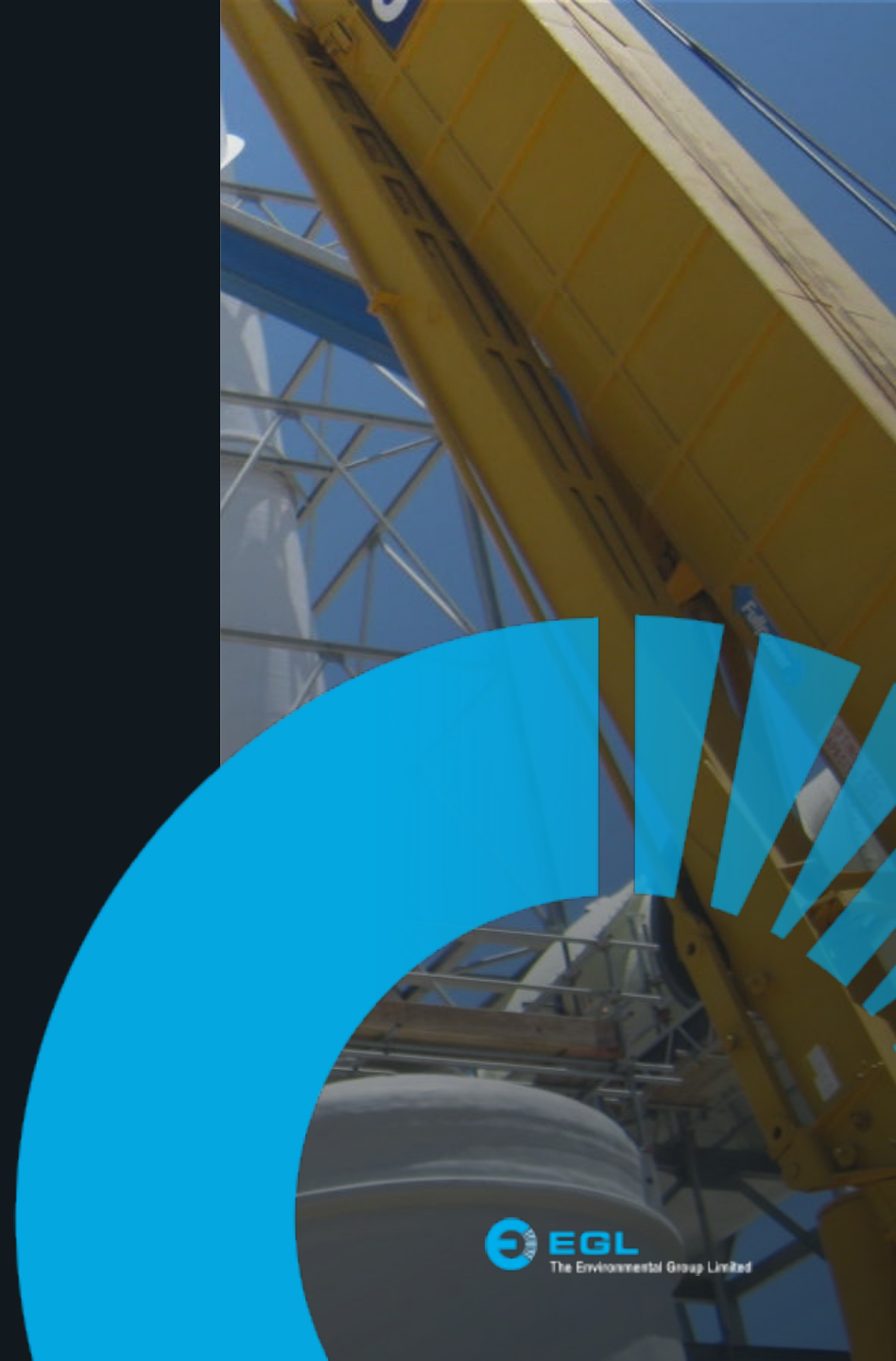
